#### **Qualifying Groups**

- COMMUNITY GROUP An individual or special interest/community group that is running an event of obvious benefit to the community and whose primary concern is not to make a profit, even if selling tickets to cover costs (excluding registered businesses, individual ABN holders, registered not for profit or registered charities)
- PRIVATE HIRER An individual or group utilising the space for personal/social purposes (eg. birthday function, christening, family reunion, social function)
- The purpose of the Hirers Public Liability Insurance is for one off users and not regular users. See below categories that we will not provide cover for under this arrangement unless specifically approved by a member of the Risk & Compliance Team.

#### Non - Qualifying Groups

- COMMERCIAL It is expected that corporations, companies and registered businesses and ABN holders hold their own public liability insurance and that such a policy should extend/be extended to cover the event for which the hall is being hired. Exceptions may be made for individual ABN holders where public liability insurance is not held or existing public liability insurance cannot be extended to cover the event.
- REGISTERED NOT FOR PROFIT ORGANISATION It is expected that registered notfor-profit organisations hold their own public liability insurance and that such a policy should extend/be extended to cover the event for which the hall is being hired.
  Exceptions may be made in certain circumstances in the event public liability insurance is not held by the organisation or cannot be extended for the event.
- REGISTERED CHARITY It is expected that registered charities hold their own public liability insurance and that such a policy should extend/be extended to cover the event for which the hall is being hired. Exceptions may be made in certain circumstances in the event public liability insurance is not held by the charity or cannot be extended to cover the event.
